Details of the appeal procedures are set out on the back of the Notice of Decision that you will receive. An appeal must be made on a prescribed form (obtainable from the Victorian Civil and Administrative Tribunal) and must be accompanied by the prescribed fee. A copy must be given to Council, the Applicant and all Objectors. The closing date for appeals is 21 days after Council gives notice of its decision.
7. The Applicant can also appeal Council's decision. The provisions are set out in the Refusal of Planning Application Notice that will be issued at that time.
